After having completed the online application process (www.gdeadmissions.gov.za) and having obtained a reference number from the online application system, please complete the attached learner information form and email / fax to Robert Hicks School (NB please turn over for list of required supporting documents).

<u>Please note the learner information form is not an application for admission form.</u>
The GDE online application system is the ONLY way to apply for admission for Grade 1 (and Grade 8).

The closing date for applications is 25 July 2020.

THE PLACEMENT OF LEARNERS:

The criteria used for the placement of learners are as follows:

- 1. Learners whose **home address** is in the School's feeder zone*. Learners are placed at the school closest to their home address within the feeder zone. Should the School still be able to accommodate learners after all the learners resident in the School's feeder zone*, learners meeting the applicable criteria below will be offered placement:
- 2. Learners who in 2020 have a **sibling** enrolled at Robert Hicks School in Grade 1-6. Unfortunately the applications for siblings of learners in Grade 7 in 2020 at Robert Hicks School do not qualify for application based on sibling status;
- Learners whose <u>parent/s work</u> in the School's feeder zone*;
- 4. Learners whose home address is outside the School's feeder zone* but **within 30km** of the School;
- 5. Learners whose home address is **more than 30km** from the School.

The outcome of the application will be communicated directly to parents by the GDE.

THE FOLLOWING DOCUMENTS ARE REQUIRED:

After completion of the online application, please check against the following list that all required documents are attached to this information form if they were not uploaded on the www.gdeadmisisons.gov.za site:

- * Fully completed information form (incomplete forms cannot be accepted).
- * Learner's birth certificate. In the case of an application for a sibling, an un-abridged birth certificate is required.
- * Both parents' and/or **legal** guardians' Identity Documents. If a parent is deceased, please include a copy of the death certificate.
- * Proof of residential address (i.e. municipal account). If the account is not in the name/s of the parent/s please include a sworn affidavit confirming residence at the address.

<u>If the residential address is in the feeder zone*, the following are also required:</u>

- Latest (not older than 2 months) municipal account which must be in either the mother's or father's name. Should the municipal account be in the name of a stepparent, the marriage certificate of the parents must be provided as well as a copy of the Identity Document of the step-parent; and
- <u>In the case of a rental property, the following documents are required in addition to the municipal account:</u>
 - Legal lease agreement for the property. Lease agreement must be in either the mother's or father's name. If the lease agreement is in the name of a stepparent, the marriage certificate of the parent must be provided as well as the Identity Document of the step-parent; and
 - 2. <u>A letter from the rental agent</u> (e.g. Huurkor, Ithemba, Pretor etc.) confirming the occupants of the property, specifically including the name of the learner for which application is being made.
- * If the application is based on a <u>parent working in the feeder zone</u>*, a letter confirming employment of the parent/s <u>working</u> in the zoned area, on the Employer's letterhead and signed by the HR Manager or Senior Manager.
- * Immunization card (front page with baby's details and the immunization records page only).
- * Foreign nationals must provide valid passports, permanent residence permits, study permits or Refugee and Asylum Seeker documents for both parents as well as the learner.
- * A certified copy of any court order confirming guardianship or custody or any similar right of the person ("parent") claiming such right.
